### Temporary Relaxation of the EU and GB Drivers' Hours Rules – Extended

The temporary relaxation of the EU and GB drivers' hours rules has been extended until 31 May 2020.

Temporary Relaxation of the EU and GB Drivers' Hours Rules – Operator obligations

Operators whose drivers make use of the temporary relaxations (which apply until 23:59 hours on 21 April) must adapt their existing drivers' hours and tachograph analysis systems to manage this additional compliance obligation. Current tachograph analysis software will not be configured to take account of the relaxations and will instead report wholesale infringements where the relaxations are relied on. Operators and transport managers must therefore conduct a detailed review of every infringement to establish whether in fact it is an infringement or whether one of the relaxations applies (and, if it does, has the driver complied with the relaxed rules and produced/handed in the required records). This is a labour intensive and time-consuming process but it is vital for enforcement purposes. ## Coronavirus Job Retention Scheme - Eligibility Cut-Off Date Extended

The Government announced on 15 April 2020 that the eligibility cut-off date for Coronavirus Job Retention Scheme is to be extended to 19 March 2020 (formerly the date was 28 February 2020). The implication of this is that, potentially, thousands more workers can be furloughed.
